**1. DESCRIPTION:** The Boost Mobile Soccer Sweepstakes 2026 is sponsored by Boost Mobile, a division of Boost SubscriberCo L.L.C. (the “Sponsor”) and consists of two separate random-draw promotions (each, a “Promotion”; together, the “Promotions”). Each Promotion may also be referred to herein using the following name which corresponds to its related prize: the “**Tickets Promotion**” (which begins at 12:00 AM Mountain Time [“MT”] on April 27, 2026, and ends at 11:59 PM MT on May 25, 2026) or the “**Jerseys Promotion**” (which begins at 12:00 AM MT on April 27, 2026, and ends at 11:59 PM MT on July 13, 2026). The time during which a Promotion is open for entry may be referred to herein as an “Entry Period”. Entries received for one Promotion will not be carried forward into the other Promotion’s drawing. Sponsor’s computer is the official time-keeping device for the Promotions.

**2. ELIGIBILITY:** Each Promotion is only open to legal residents of the 50 United States and the District of Columbia (the “Eligibility Area”) who are 18 years of age or older as of the date of entry. Employees, officers, directors, agents, successors, and assignees (and their immediate families regardless of where they live, or members of the same households [whether related or not]) of Sponsor, its parent companies, divisions, affiliates, subsidiaries, agents, retail partners, wireless technology providers, promotional partners, advertising/promotion agencies and prize suppliers including Gold N Fish Marketing Group LLC (“Administrator”), and any other entities affiliated with the administration of the Promotions are not eligible to participate in a Promotion or to

receive a prize. Sponsor/Administrator's determinations of eligibility are final and may be made at any time. VOID OUTSIDE OF THE ELIGIBILITY AREA AND WHERE PROHIBITED OR RESTRICTED BY LAW. All federal, state and local laws and regulations apply.

**3. AGREEMENT:** BY PARTICIPATING IN A PROMOTION IN ANY WAY, EACH PARTICIPANT REPRESENTS AND WARRANTS THAT THEY: [A] ARE SOLELY RESPONSIBLE FOR THEIR CONDUCT, TRANSPORT, SAFETY, PREPARATION FOR WEATHER AND ANY OTHER MATTERS RELATING TO PARTICIPATION IN A PROMOTION; [B] HEREBY ACCEPT ALL INHERENT RISKS AND DANGERS ASSOCIATED WITH A PROMOTION, INCLUDING BUT NOT LIMITED TO RISKS OF PROPERTY DAMAGE, PERSONAL INJURY, OR DEATH; [C] HAVE READ THESE OFFICIAL RULES, AND AGREE TO BE BOUND BY THEM, AND BY THE INTERPRETATIONS OF THESE OFFICIAL RULES BY THE SPONSOR AND ADMINISTRATOR, AND BY THE DECISIONS OF THE SPONSOR AND ADMINISTRATOR, WHICH ARE FINAL IN ALL MATTERS RELATING TO THE PROMOTIONS; [D] AGREE TO RELEASE AND HOLD HARMLESS THE RELEASED PARTIES AS FURTHER DETAILED IN SECTION 7; [E] ACKNOWLEDGE COMPLIANCE WITH THESE OFFICIAL RULES; [F] WARRANT THAT ALL INFORMATION PROVIDED BY PARTICIPANT IN CONNECTION WITH A PROMOTION IS TRUE, ACCURATE AND COMPLETE; AND [G] AGREE TO COMPLY WITH ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS.

**4. TO ENTER:** First, launch the online entry form ("Entry Form") on your web-enabled device by either: (a) scanning a QR Code which appears on a Promotion advertisement, or (b) following the provided link in an email or digital advertisement which offers entry into a Promotion. Once you have accessed the Entry Form, follow the Entry Form's instructions to: (i) (while such a choice is available) select the Promotion you would like to enter (Tickets Promotion or Jersey Promotion); then (ii) complete all required Entry Form fields and submit the completed Entry Form so that it is received by Sponsor's server during the Promotion's Entry Period. Eligible entries will be included in the applicable Drawing Pool as described in Section 5 below, based on which Promotion the entrant chooses to enter (while such a choice is available), and the date the entry is received.

Note that scanning a QR Code itself is NOT an entry; follow the Entry Form's on-screen instructions to complete your entry. To access the Entry Form via a QR code, your web-enabled device must have a camera and QR Code reading application installed. QR readers may not be available through all wireless carriers or on all web-enabled mobile devices. Installation of a QR reader is subject to your mobile device's

compatibility. Sponsor/Administrator is not responsible for any QR Code reader website, download, claim or otherwise related to the entrant's attempt (successful or otherwise) to install a QR Code reader. Sponsor/Administrator do not endorse any particular QR Code reader or company products, and any such download is at the sole risk of the participant. Check the user guide for your device and/or application for further instructions if needed. You are solely responsible for any related equipment, application, and wireless charges pursuant to your wireless service provider's rate plan. Please consult your mobile device/service provider for more information.

**Further, completing the online entry form also constitutes your willful agreement to opt-in to Sponsor's email marketing list. You may unsubscribe from email marketing communications at any time by clicking the "Unsubscribe" link provided in such correspondence or by visiting <https://dish.com/donotcontact/wireless/> and requesting to be added to the Do Not Contact List. If you decide to opt out, this will not affect your ability to enter the Sweepstakes or your odds of winning a prize in a Promotion. See also Section 12 ("COLLECTION AND USE OF PERSONAL INFORMATION") below.**

**There is a limit of one (1) entry per person/email address/web-enabled device, per day, regardless of method of entry. For the avoidance of doubt, this entry limit will be enforced overall for the Sweepstakes, not per Promotion.** Multiple entrants are not permitted to share the same email address or web-enabled device. Entries are void if late, unreadable, inaccurate, incomplete, tampered with, forged, mechanically reproduced, irregular in any way or otherwise not in compliance with these Official Rules. Entries submitted in excess of stated limits will be void. Use of any automated system to enter (as determined by Sponsor/Administrator in their sole judgment) is prohibited and will result in disqualification at Sponsor/Administrator's sole discretion. Any attempt by any entrant to obtain more than the stated maximum number of entries by using multiple/different accounts, identities, registrations, or logins, or through any other methods, may void all of that entrant's entries and that entrant may be disqualified. Sponsor/Administrator are under no obligation to correspond about entries, nor are Sponsor/Administrator required to acknowledge their receipt of entries. Sponsor/Administrator reserves the right to, and at their sole discretion may, reject any entry for failure to comply with any applicable entry requirements. Proof of submission of entry does not constitute proof of receipt of entry. In the event of a dispute as to the identity of the entrant associated with any entry, the authorized account holder of the email address associated with the entry, at time of submission, will be deemed to be the entrant. The "authorized account holder" is the natural person assigned to the email account by the applicable email account provider. Potential winner(s) may be required to show proof of being the authorized account holder. In the event a dispute regarding

the identity of the person who actually submitted an entry cannot be resolved to Sponsor/Administrator's satisfaction, the affected entry will be deemed ineligible. Normal Internet access and usage charges imposed by your online service will apply. If you participate from your wireless device, such activity will be subject to the charges pursuant to your wireless service provider's rate plan. The eligible entries received for a particular drawing may be referred herein as a "Drawing Pool". On or about each of the Drawing Dates listed above, an independent judging organization will conduct a random drawing from among the eligible entries received for the applicable Drawing Pool, to award the number and type of prizes listed above.

**Tickets Prizes:** Each "Tickets Prize" will consist of two (2) tickets to winner's choice of one (1) soccer game selected from among a Sponsor-determined list of options, currently anticipated to be: (a) 6/6/26 Bolivia vs Scotland in Harrison NJ; -or- (b) 6/6/26 Brazil vs Egypt in Cleveland OH; -or- (c) 6/6/26 Argentina vs Honduras in College Station TX; -or- (d) 6/9/26 Argentina vs Iceland in Auburn AL (note that the available games, locations, and dates are subject to change prior to winner notification, in Sponsor's sole discretion). Each Tickets Prize has an approximate retail value ("ARV")

of \$160. Tickets Prizes do not include any travel, meals, lodging, incidentals, nor any other item or service besides that which is described herein as being included. Seat type and location will be selected by Sponsor in its sole discretion. Tickets Prize winners may be required to create a free online account with a leading online ticketing platform selected by Sponsor in its sole discretion, in order to receive their prize tickets via that platform. Sale or transfer of Tickets Prizes is prohibited. Use of Tickets Prizes is subject to all terms printed/referenced on the applicable ticket. If any element of a Tickets Prize is cancelled, delayed, or postponed beyond the reasonable control of Sponsor, the remaining portion of the applicable will be awarded as complete and final (if any), and no substitute compensation or refund will be offered. In the event a person using a Tickets Prize engages in behavior that (as determined by Sponsor or any prize element operator in its or their sole and absolute discretion) is obnoxious, inappropriate, threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, such party reserves the right to terminate the applicable prize experience early for such person(s) without further compensation.

**Jersey Prizes:** Each “Jersey Prize” will consist of a soccer jersey selected by Sponsor with an ARV of \$100. As part of the winner verification process described in Section 6 below, Jersey Prize winners will have the opportunity to select their preferred represented country and size for the Jersey, subject to availability and Sponsor’s approval.

See Section 6 below for additional prize restrictions and winner notification details. Any prize details not specified will be determined by Sponsor in its sole discretion. Eligible entries received for a particular Drawing Pool will not be included in any other Drawing Pool’s drawing. Odds of winning depend on the number of eligible entries received for each Drawing Pool. **There is an overall limit of one (1) prize per person/household, across all of the Promotions.**

**6. WINNER NOTIFICATION AND GENERAL PRIZE RESTRICTIONS:** The name and city/state of a potential winner may be announced online prior to verification; however, any such announcement is not a guarantee of eligibility. A potential winner will be notified by Administrator or Administrator’s designee by email at the email address provided at the time of entry, and/or by phone call/voicemail and/or text message to the phone number provided at the time of entry. Any such notification will instruct the potential winner to reply as specified within twenty-four hours after the time that the notification email was sent. A potential winner must reply as instructed to confirm their eligibility and ability to accept the prize, and provide their complete contact information and answers to an eligibility survey within such twenty-four hour period, or they will be disqualified. In Sponsor’s/Administrator’s sole discretion, a potential winner may further

be required to complete and return a declaration of eligibility, a liability release, a publicity release (where legal), and to provide a copy of a valid government-issued identification card as proof of age and identity, any of which must be returned within the time period specified by Sponsor/Administrator or its designee at the time of such request. Proof of identity, age, and legal residence may be required to claim a prize. In the event of disqualification of a winner, at Sponsor/Administrator's sole discretion the prize may be awarded to an alternate winner selected from among the remaining applicable eligible entries via the means of winner determination described herein, pending verification of eligibility. No responsibility is assumed for any incorrect or missing contact information associated with an entry, or any change of such contact information after entry submission. Any prize details and restrictions not specified herein will be determined by Sponsor in its sole discretion. No prize transfer. No prize substitution except at Sponsor/Administrator's sole discretion due to unavailability, in which case a prize of comparable or greater value will be awarded. **7. RELEASE AND LIMITATIONS OF LIABILITY:** BY PARTICIPATING IN A PROMOTION, PARTICIPANTS HEREBY AGREE TO RELEASE AND HOLD HARMLESS SPONSOR, ADMINISTRATOR, AND META PLATFORMS, INC. (AND ANY OTHER SOCIAL MEDIA PLATFORM USED TO PROMOTE A PROMOTION), TOGETHER WITH THEIR RESPECTIVE PARENT COMPANIES, DIVISIONS, AFFILIATES, SUBSIDIARIES, AGENTS, RETAIL PARTNERS, WIRELESS TECHNOLOGY PROVIDERS, PROMOTIONAL PARTNERS, ADVERTISING/PROMOTION/JUDGING AGENCIES, PRIZE SUPPLIERS, AND ANY OTHER ENTITIES AFFILIATED WITH THE ADMINISTRATION OF A PROMOTION,

TOGETHER WITH THE RESPECTIVE OFFICERS, DIRECTORS, SHAREHOLDERS, EMPLOYEES, AND AGENTS OF EACH (AFOREMENTIONED INDIVIDUALS AND ORGANIZATIONS COLLECTIVELY, THE "RELEASED PARTIES") FROM AND AGAINST ANY AND ALL LOSSES, DAMAGES, RIGHTS, EXPENSES, COSTS (INCLUDING REASONABLE ATTORNEYS' FEES), CLAIMS, LIABILITIES (INCLUDING SETTLEMENTS) AND ACTIONS OF ANY KIND ARISING IN WHOLE OR IN PART, DIRECTLY OR INDIRECTLY, FROM A PROMOTION OR PARTICIPATION IN ANY PROMOTION-RELATED ACTIVITY (INCLUDING WITHOUT LIMITATION THE REMOVAL FROM ANY WEBSITE OF, OR DISCONTINUATION OF ACCESS TO, ANY MATERIALS), OR RESULTING DIRECTLY OR INDIRECTLY, FROM THE ACCEPTANCE, PARTICIPATION IN, POSSESSION, USE, OR MISUSE OF ANY PRIZE AWARDED IN CONNECTION WITH A PROMOTION, INCLUDING WITHOUT LIMITATION PERSONAL INJURY, DEATH, AND/OR PROPERTY DAMAGE, AS WELL AS CLAIMS BASED ON PUBLICITY RIGHTS, DEFAMATION, AND/OR INVASION OF PRIVACY AND THE COLLECTION, USE AND/OR SHARING BY THE RELEASED PARTIES OF PERSONALLY IDENTIFIABLE INFORMATION OF THE ENTRANTS. WITHOUT LIMITING THE FOREGOING, THE PROMOTIONS, ALL PRIZES, AND ALL MATERIALS PROVIDED ON OR THROUGH ANY PROMOTION-RELATED WEBSITE ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT.

UNDER NO CIRCUMSTANCES, INCLUDING, BUT NOT LIMITED TO, NEGLIGENCE, SHALL THE RELEASED PARTIES BE LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF PARTICIPATION IN A PROMOTION OR ANY PRIZE, EVEN IF ANY OR ALL OF THE FOREGOING OR ANY OF THEIR AUTHORIZED REPRESENTATIVES HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. **8. GENERAL:** Released Parties and Internet/wireless access providers are not responsible for: (a) unauthorized human intervention in a Promotion, including the actions of an entrant or other individuals in connection with a Promotion, such as attempts to circumvent these Official Rules or otherwise interfere with the

administration, security, fairness, integrity or proper conduct of a Promotion; (b) incomplete, lost, late, misdirected, damaged, garbled, or illegible entries; (c) any technical malfunction, human error, lost/delayed data transmission, omission, interruption, deletion, defect or line failure in connection with any telephone network, computer equipment, software, server or any combination thereof; (d) any injury or damage to entrant's or any other person's computer or other equipment related to or resulting from participation in a Promotion; (e) printing errors or any errors made in the advertisement of a Promotion; (f) errors in the administration of a Promotion or the processing of entries; (g) content filtering or any malfunction, error or failure which may impact the accessibility of any Promotion-related website, entries, or the transmission or receipt of winner verification notices (or other communications with winners); (h) claims based on publicity rights, defamation and/or invasion of privacy and the collection, use and/or sharing by Released Parties of personally identifiable information of the entrants; or (i) death, injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from a participant's participation in a Promotion or the receipt, use, misuse, or possession of any prize. In the event of any conflict between any details contained in these Official Rules and the details contained in any Promotion advertising materials, the details as set forth in these Official Rules shall prevail. If, for any reason, a Promotion (or portion thereof) is not capable of running as planned by reason of damage by computer virus, worms, bugs, tampering, unauthorized intervention, fraud, technical limitations or failures, by reason of any acts of God, terrorist acts, disease, pandemic, earthquake, war, fire, flood, unusually severe weather, strikes or legal disputes (whether legal or illegal), industry conditions, bankruptcy or liquidation, marketplace demands, applicable law, unforeseen obstacles or any other causes which, in the sole opinion of Sponsor, could corrupt, compromise, undermine or otherwise affect the administration, security, fairness, integrity, viability or proper conduct of a Promotion, Sponsor reserves the right in its sole and absolute discretion to cancel, terminate, modify or suspend all or any part of a Promotion, and to select the applicable winner(s) from among the applicable eligible, non-suspect entries received for that Promotion up to the time of such cancellation, termination, modification or suspension, as applicable, or to proceed in such a manner as may be deemed fair and equitable by Sponsor in its sole discretion. Entry must be made by the entrant and via the means described in these Official Rules. You are not a winner until your entry has been verified and you have complied with these Official Rules. If any provision of these Official Rules is found to be invalid or unenforceable by a court of competent jurisdiction, such provision will be severed from the remainder of these Official Rules, which will otherwise remain in full force and effect. Sponsor/Administrator's failure to enforce any portion of these Official Rules does not affect or waive Sponsor/Administrator's right to enforce any portion of Official Rules at any time. Headings and captions are used in these Official Rules solely for convenience of

reference, and shall not be deemed to affect in any manner the meaning or intent of these Official Rules or any provision hereof. When terms such as “may” are used in the Official Rules, Sponsor/Administrator has sole and absolute discretion. Participants agree to waive any rights to claim ambiguity or any deficiency in these Official Rules or in any Promotion, including its administration.

Participants further understand and agree that all rights under Section 1542 of the Civil Code of California (“Section 1542”) and any similar law of any state or territory of the United States that may be applicable with respect to the foregoing release are hereby expressly and forever waived. Participants acknowledge that Section 1542 provides that: “A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.” The releases hereunder are intended to apply to all claims not known or suspected to exist with the intent of waiving the effect of laws requiring the intent to release future unknown claims.

**9. CONDUCT:** Sponsor/Administrator reserves the right, at any time and at its sole discretion, to disqualify and/or deem ineligible to participate in a Promotion or any future Sponsor promotions, any individual it suspects: (a) to be tampering with the entry process or the operation of a Promotion or any related website; (b) to be acting in violation of these Official Rules or Sponsor’s privacy policy or other applicable terms, conditions or guidelines; (c) to be acting in bad faith or in a disruptive manner, or with the intent to annoy, abuse, threaten or harass any other person; (d) to have failed to agree to these Official Rules; or (e) to be in violation of these Official Rules. CAUTION: ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO UNDERMINE THE LEGITIMATE OPERATION OF A PROMOTION IS A VIOLATION OF THESE OFFICIAL RULES AS WELL AS CRIMINAL AND CIVIL LAWS. SHOULD SPONSOR BELIEVE OR BECOME AWARE THAT SUCH AN ATTEMPT HAS BEEN, IS BEING, OR WILL BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK REMEDIES AND DAMAGES FROM ANY RESPONSIBLE ENTRANT(S) AND OTHER RESPONSIBLE INDIVIDUAL(S) IN THE ATTEMPTED DAMAGE TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING WITHOUT LIMITATION CRIMINAL PROSECUTION.

**10. PUBLICITY:** By participating in a Promotion, you grant to Sponsor and its affiliated companies the right, except where prohibited by law, to use your name, likeness, picture, address (city and state), voice, biographical information, entry, any recordings/images/video you provide to Sponsor in connection with the Promotion/prize, and any of your written or oral statements about the Promotion/prize or Sponsor’s

products/services (collectively, the “Materials”), for advertising and promotional purposes in promoting or publicizing Sponsor, its affiliated companies, and the products or services of each, in any and all media without limitation as to time or territory, without compensation unless required by law. You shall have no right of approval, no claim to compensation, and no claim (including, without limitation, claims based on invasion of privacy, defamation, or right of publicity) arising out of any use, blurring, alteration, or use in composite form of the Materials.

**11.
