

Infinite Access for iPhone Terms

Effective as of June 30, 2026, the Infinite Access for iPhone plan is no longer being offered by Boost Mobile. Existing customers enrolled in this plan prior to June 30, 2026 (or July 14, 2026 for customers who purchased the plan through Apple) may continue to enjoy all the benefits, credits, and upgrade privileges of this plan, subject to compliance with the Infinite Access for iPhone terms and the Boost Mobile Terms and Conditions.

Specific iPhone models may not be available. Prices vary based on iPhone model selected. Offer and Offer Terms subject to modification or termination at any time in Boost Mobile's sole discretion. Taxes on full pre-credit retail price of phone (the "List Price") due at sale. Monthly \$65 fee includes unlimited talk, text and data and a credit for the latest available iPhone family model (credit value between \$829.99 and \$1,000.00 depending on the specific promotion (the "Phone Credit Value")) and does not include taxes, regulatory fees or surcharges. iPhone models over customer's Phone Credit Value may result in an additional monthly fee. Available only for qualified customers who finance an iPhone family model on the Infinite Access plan; other phones are not eligible. Switching plans may cause you to lose current plan, promotional offers, or feature benefits. Max 10 lines. If customer fails to activate the iPhone on the Infinite Access wireless service plan within 30 days following the date the iPhone is purchased, Boost Mobile will charge customer full List Price of the purchased iPhone using the payment method on file. Customers using more than 30GB of data will experience speeds reduced to 512kbps for the remainder of the billing cycle. Unlimited data in US only. Coverage not available in some areas; Boost Mobile is not responsible for its' partners' networks. Customers are eligible for annual upgrade from Boost Mobile (i.e., each year that they remain on the Infinite Access plan) to a qualifying phone after maintaining at least 12 active months on the Infinite Access plan in good standing (including, without limitation, remaining current in their payments) for such year. Upgrade requires trade-in to Boost Mobile of current Infinite Access plan phone (must be the same IMEI as the phone specified in customer's finance agreement or, if applicable, replacement phone provided pursuant to a valid Boost Protect claim) in acceptable condition as set forth in the Boost Mobile Terms and Conditions. Customer will receive their Phone Credit Value applied to their new phone upon upgrade. Failure to return current phone within 30 days from the shipment of the new phone may result in customer being charged the entire remaining balance on that phone. After 30 days from the shipment of the new phone, customer may receive the fair market value of their current phone upon return of the phone to Boost Mobile. 36-Month Finance Agreement: Infinite Access plan requires a 36-month finance agreement with Boost Mobile for the phone included, upgrading ends current financing agreement and any device promotion or deposit reimbursement credits and begins new 36 -month financing agreement. The customer's Phone Credit Value will be applied in equal amounts over a 36-month period depending on current promotion and model of iPhone customer chooses as long as customer remains active in good standing on the Infinite Access plan. If customer's Infinite Access plan is canceled,

terminated or suspended (including cancellation by customer), credits are forfeited and customer will be immediately responsible for the outstanding balance due on the finance agreement. See finance agreement for full details. Early payment forfeits remaining credits. Customer is not required to upgrade and trade-in their phone every year to participate in the Infinite Access plan. North America Connect: Enrolled customers receive 5GB of data per month while roaming in Mexico and Canada, unlimited talk, text across North America while roaming, plus unlimited talk and text from the U.S. to Mexico and Canada. Customer must reside in the U.S. and primary usage must occur in the U.S.
